

CONSIDERABLE GAPS IN FLOOD RISK REVEALED

- New research shows over 383K homes are at risk of flooding
- Riverine flooding is a major threat of flooding to Tennessee for well over 100 years
- Increasing rainfall has left much of the state still vulnerable to flood events
